#### APPLICATION RANGE:

Blue Star - ultra-wetting cleaner. Highly active maintenance cleaner for strongly water resistant elastic floor coverings. Cleaner takes off residues. Not leaving any streaks on cleaned surfaces. Optimizes maintenance cleaning in single- and double -step wiping technologies. Specially invented for use on **PU reinforced wear layers**. Dissolving possible lime scales - as well as oily and fatty deposits on all objects in **sanitary areas** - when used regularly. Blue Star is meeting the cleaning recommendations of armature producers.

#### INSTRUCTION FOR USE AND DOSAGE:

**Manually:** 20-40 ml to 8 L water (0.25-0.5 %). For extreme soiling use higher dosage. Work on surface by single or two step wiping technology. Spray methode - use 40 ml on 500 ml water (8 %), in sanitary areas use pure/undiluted.

**Automatic machine cleaning:** Depending on instruction of dosage from cleaning machine manufacturer or otherwise till 1 % (10 ml on 1 L water) diluted. For extremely strong soiling - spray over surface floor with machine. Prior to using pads for machine cleaning. Use relevant scrubbing pads subj. to floor surface material and relevant to conditions. Good pads will provide better results.
