APPLICATION RANGE:

For fatsolvent cleaning of all washable surfaces and equipments. In food stuff processing areas, such as large kitchens, canteens, butcher shops and dairy farms etc. - especially for the cleaning of highly fat contaminated floors and working surfaces.

INSTRUCTIONS FOR USE AND DOSAGE:

Manual cleaning: Depending on degree of soiling dose from 20-50 ml per 8 L water.

If necessary increase the dosage. **Machine cleaning:** Follow instructions of machine producer - use up to 6 % (60 ml per 1000 ml water). For highly contaminated floor surfaces - use machine and spray dilution onto floor prior to pad cleaning. By selecting good quality pads the cleaning results/optic will be increased for best results.
