Alkylbenzene sulfonate, Sodium carbonate, Sodium lauryl ether sulfate, Terpene hydrocarbons, By-products, 1,2-benzisothiazol-3 (2H) -one

## HAZARDS TO HUMANS AND THE ENVIRONMENT:



Warning

EUH208: Contains Hydrocarbons, terpene processing by-products, citral. May produce an allergic reaction.  
H315: Causes skin irritation.  
H317: May cause an allergic skin reaction.

## SAFETY MEASURES AND CODES OF CONDUCT:
