## HAZARDOUS MATERIAL:

## HAZARDS TO HUMANS AND THE ENVIRONMENT:



Danger

H314: Causes severe skin burns and eye damage.

## SAFETY MEASURES AND CODES OF CONDUCT:

P102: Keep out of reach of children.

P280: Wear protective gloves/eye protection.

P301+330+331: IF SWALLOWED: rinse mouth. Do NOT induce vomiting.

P303+361+353: IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower.

P305+351+338: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

P310: Immediately call a POISON CENTER or doctor/physician.



Remove contaminated, saturated clothing immediately. Avoid contact with skin, eye and clothing. When using do not eat, drink, smoke, sneeze. Wash hands before breaks and after work.

## FIRST AID:



**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Transfer to hospital if there are burns or symptoms of poisoning.

**Eye contact:** Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

**Ingestion:** Wash out mouth with water. If conscious, give half a litre of water to drink immediately. Do not induce vomiting. Immediate hospitalization.

**Inhalation:** Move affected person into fresh air. In case of respiratory tract irritation, consult a physician.

## PROPER DISPOSAL:

Dispose of waste according to applicable local, state and federal regulations.
