HAZARDS TO HUMANS AND THE ENVIRONMENT:



Danger

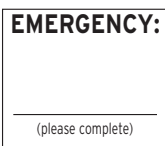
EUH031: Contact with acids liberates toxic gas.
H314: Causes severe skin burns and eye damage.

SAFETY MEASURES AND CODES OF CONDUCT:

P102: Keep out of reach of children.
P280: Wear protective gloves/eye protection.
P305+351+338: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
P303+361+353: IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower.
P301+330+331: IF SWALLOWED: rinse mouth. Do NOT induce vomiting. IF SWALLOWED: rinse mouth. Do NOT induce vomiting.
P304+340: IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing.
P312: Call a POISON CENTER or doctor/physician if you feel unwell. Remove contaminated, saturated clothing immediately. Avoid contact with skin, eye and clothing. When using do not eat, drink, smoke, sneeze. Wash hands before breaks and after work.



CONDUCT IN EMERGENCIES:

Water spray jet. Co-ordinate fire-fighting measures to the fire-surroundings.

FIRST AID:



Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a doctor if skin irritation.
Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.
Ingestion: Wash out mouth with water. Let water be drunken in little sips (dilution effect). Do not induce vomiting. Medical treatment necessary.
Inhalation: Provide fresh air.

PROPER DISPOSAL:

Dispose of waste according to applicable local, state and federal regulations.
Appropriate disposal/packaging: Completely emptied packings can be recycled.
