HAZARDS TO HUMANS AND THE ENVIRONMENT:



Danger

H314: Causes severe skin burns and eye damage.
EUH208: Contains triisobutylphosphat. May produce an allergic reaction.

SAFETY MEASURES AND CODES OF CONDUCT:

P102: Keep out of reach of children.
P280: Wear protective gloves/eye protection.
P305+351+338: IF IN EYES: Rinse cautiously with water for several minutes.
Remove contact lenses, if present and easy to do. Continue rinsing.
P303+361+353: IF ON SKIN (or hair): Remove immediately all contaminated clothing.
Rinse skin with water/shower.
P301+330+331: IF SWALLOWED: rinse mouth. Do NOT induce vomiting.
P310: Immediately call a POISON CENTER or doctor.



Avoid contact with skin, eye and clothing. When using do not eat, drink, smoke, sneeze.
Wash hands before breaks and after work.
