APPLICATION RANGE:

Prestan Stainless Steel Maintenance cleans, cares and protects all surfaces of none-corrosive steel – as well as objects made from chromium, alumi-

num and anodized

surfaces, nickel and brass. Do not use on surfaces in direct contact with food, for example worktops in kitchen areas or food processing.

INSTRUCTIONS FOR USE AND DOSAGE:

Initial maintenance product for stainless steel and above listed materials.

Remove coarse dirt deposits of the surface to be cleaned. We recommend to use Kraftreiniger A (Power Cleaner A). After cleaning - take off chemical agents with clear water. Add Prestan Stainless Steel Maintenance to a dry cleaning cloth. Distribute evenly on surface. Take off excess of product. Do not polish again. For daily maintenance care - use product only on stains of metal surface. If improperly applied - and for claims resulting from such improper handling - there will be no legal claims accepted.
