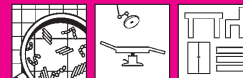

APPLICATION AND DOSAGE:

Budesin Spray Off QF is ready for use. The surfaces and objects to be disinfected must be sprayed until they are fully wetted.

Contact time: 60 sec. - Clean the surface with a dry, clean cloth later.

Please note: Application quantity max. 50 ml/m².
