APPLICATION RANGE:

For daily maintenance cleaning in out- and indoor pools, industrial and kitchen areas, for safe removal of soiling and dirt deposits, fatty and oily stains. Preferred for use on alkali resistant surfaces of ceramic and metal materials. **Look for chart with application recommendations.**

INSTRUCTIONS FOR USE AND DOSAGE:

Power Cleaner A – either concentrated or in 100–200 ml dilution for 8 L water (1.25–2.5 %). If necessary, leave on surface to penetrate well – then clean – take off soiled water and rinse after well with clear water.

Machine cleaning: Subj. to recommendations of machine producers – use up to 1 % dosage to water volume. In case of extreme soiled surfaces – walk machine by spraying solution onto surface – before using the –pad-cleaning energy. Use first quality pad systems for better and improved cleaning results.

Conduct a material compatibility test on a small area before starting.

If improperly applied – and for claims resulting from such improper handling – there will be no legal claims accepted.
