APPLICATION RANGE:

For cleaning of all alkali and water resistant hard coverings and surfaces made of PVC, artificial material, artificial stones as well as industrial coverings typical for repair and workshops, supermarkets, shopping malls, cantines and other large surface projects.

INSTRUCTIONS FOR USE AND DOSAGE:

Manual cleaning: Depending on degree of soilage dilute 1:1 (4 L on 8 L water) up to 1:20 (400 ml on 8 L water) Use cold water. Mop and distribute over surface - before scrubbing or using high performing mops.

For machine cleaning: Follow instructions of machine producers - dilute up to max 1 % to water tank. Volume - for highly contaminated floor surfaces spray solution by machine over surface - then use proper cleaning pads. Good quality and proper pads will contribute to a better optic and cleaning performance!

If used in **high pressure equipment** dilute by 1:5 till 1:10 with water. Please consider the advises of the pressure units manufacturer.

Conduct a material compatibility test on a small area before starting.

If improperly applied - and for claims resulting from such improper handling - there will be no legal claims accepted.
